Mayor Lundy -Once again we welcome to our meeting at this time Council you have an outline of today's agenda at this time. We need a motion for agenda is copied Councilwoman- Bryant-excuse me can we add two things to the agenda? We need and the approval for the Master plan and we need to advertisement for historic preservation Tisha Horton can write up the ad for the newspaper.

MayorLundy-do I have a second with the amendment to the agenda?

Council Marshall-Sandra Marshall second

Mayor Lundy-now I'll be ready for the discussion For the master plan we just got this this master plan contract. It has not been looked at by an attorney that I know the city attorney that I know and so before we even approve a master plan that I'm just going through it with some those I deal with the cost that the city will be obligated to pay 75,000 for, I think it would not be beneficial for us to for us to put this on the agenda for approval or out having to look at our city attorney

(Eason, Van Hartsvelt and Bryant raised hands)

Council Vanhartesvelt-I thought Mr. Lee was here to discuss the plan

Council Bryant-no he went with Mr. Phillips is here his place to talk

VanHartesvelt - I defend that this is the part where we're making a decision and it seems appropriate that the person who oversaw this process be here to discuss it and answer questions and if he's not, I think that's a reason to delay. I have no problem with the master plan, but we had to be able to hear, and have questions answered from the person who actually oversaw the process. I don't see Mr. Lee.

Bryant- no it was not Mr. Lee. It was Mr. Phillips and he has been before the council twice.

Mayor Lundy- let me find out this, so let me find out this before we move any further so that every person gives up on the council has an opportunity to address (Eason rising hand)that so that we allow this opportunity not to debate back-and-forth but to hear everybody's points of view everybody on council point of view who has something to Put to this debate yes ma'am (to Ms, Eason)

Eason- we did receive feedback from the attorney who went over the contract...

Mayor which attorney did that?

Eason, our attorney, Mr. Elliot

Mayor Mr Elliot??

Carla, if we're going to spend that kind of money, aren't we supposed to have bids? and this is the only one that brought one Ford, if we had other bits before us before we spend \$75,000

Eason- Is not a bid

Mayor- Ms. Marshall you had your hand up..

Marshall-well just to be honest about it. We just signed a contract. We signed a contract for a fair that's coming here next week and council member never had any input on it before it went. You know we didn't have an opportunity to look at it to expect it so I'm trying to see, even though the lawyer had an opportunity to look at the contract as this as well. I'm trying to see what's the difference that we're doing here. I mean you did sign a contract for the fair were here that I looked at and Mr. Phillips has been here too and three times has been a presentation and I'm just trying to see what the difference and what ways and for the ways of debate.

Mayor -to your point, the attorney look at the fair contract right with some amendment to that which included some things that you said you wanted to amend to that that were added to that contract because of the timeframe with that there was a executive decision that was made that was necessary that was made for the executive decision

that was signed after attorney was to look at this was just permitted to me when I got up on the beach and prior conversations about this master plan. It was said that there will be no calls to the city of Fort Valley in this contract compensation says that to the service rendered the developer should accept as complete payment a total of fee of \$75,000, so if our attorney saw this

Bryant -we're not we're going to eliminate this

Mayor well is our attorney on the line by chance

Bryant - that was eliminated also something about

Mayor- this is a contract that brought before the sign councilwoman Bryant

Bryant- excuse me, the contract was sent to the attorney. We went over the contract and it was stated even in here with Philip and somebody I don't know when they came in and presented us the master plan that stated that there will be no cost to the city that will be on the end that's been corrected by the attorney and no projects should not be done if not approved by the city.

Mayor -your point is well taken

Bryant-thank you

Mayor- but at the same time it is a contract for signatures and it stays. I just read estate \$75,000 so that I'm waiting to see if my city attorney who you all said the contract and gave the approval of that contract and I've been conversing with emails all day today and I haven't seen this. This just hit up here as we are will know in a minute.

Bryant-this is the second copy of this because when he first came, he was outside he came in. He gave us a copy of the master plan.

Mayor- they didn't give us a contract. This is a binding contract.

Bryant- exactly but we had the contract in the master plan

Mayor- this is the first time I'm seeing this

Bryant- No, this is not the first time you're seeing this contract

Mayor- First time I've seen this contract

Bryant-we had it before

Mayor- any other discussion?...... but I think at some point the challenges have to come in up here from the bench complaint at this complaint like that so that we can some point beyond being able to hear. I'm hoping to hear from the attorney, because you said that they said that this was an acceptable contract, and I'm saying I just got

This right now I'm just looking at it just seen it briefly and just noticing that the city and the taxpayers \$75,000 and then being told there would be no cost on the back end but this goes even deeper than that when you start trying to read (Bryant raise hand)and seeing things that need to come off here

Bryant- we need to wait till the attorney gets on here so that he can give us the facts and he is not on the line as of yet?

Howard- my thing is mayor We can't keep stalling. because this it can put a contract that will get started while waiting on the decision for the payment of 75000 Bryant- we can also put in the contract that there is no upfront fee and if you were told that we was no upfront money

Mayor -who told y'all that?

Bryant -Phillip He said that the money that they would make, they will come back here that can be scratched out of the contract. (Fred raise hand) There's a lot of things need to get started City Hall, etc., etc. etc.....

Vanhartsevelt-A contract can't be changed by of the signatures. The contract has to be changed to be agreed upon by both of the signatures if the developers are willing to write in that we don't have to pay then that's fine but we have to handle that from them. Secondly, can we vote on these two pieces separately?

Bryant- of course that's how enter them separately

Mayor-Well, we on the master plan now, and so the dialogue part the debate part is you know you know we have rights the University of Georgia program putting together been put together that will address some of our changes that are gonna be taking place with Fort Valley with citizens input from the community and so we've been told and I done heard myself, and I've been asking that from the beginning part of this up to now how much would this cost this citizen the city of fort valley and now browsing through you all have even with the different perspectives about the need that we keep prolonging these are tax players dollars so to make sure that legals followed rather than continue to make eternity decisions at the last minute without because we've been working on the agenda part of it since Tuesday

Bryant -OK I would like to I would like to retract that addition until the attorney comes on the line

Eason-he just he should be on. He's on, on the line.

Bryant- that way he can go over the contract he know the contract and the master plan

VanHartesvelt-I have a question

Lawyer Elliot mayor and council

VanHartvelt- like the mayor said if this is a valid contact that doesn't mean this contract represents City was told what's going to happen obligated under the law to execute he's not gonna say whether or not (Bryant well let's just ask him) that's what we were told or if the proposal well we can ask him well that's what lawyers do

Lawyer-Council Mary Lundy, Mayor and counselor members

Mayor- yes

Council-yes

Lawyer-this is Jim Elliott's let me just say this, I received a copy of the contract this morning. I was able to review. early this afternoon. I had some problems with the version I was sent something involving fiber optics a long-term commitment that I don't I don't think is allowed for under the state law and understand that section has been removed or is being removed again? I'm just acting on when I'm told. but what would I will say regarding the master plan provision part of the contract, and to your point mayor does provide for a \$75,000 fee specified services whether those services are what the city needs or want that's not something within my preview but the contract is legally binding upon both parties if you adopt it to provide the services that are provide the service service that are forth for in our opposition, always is to review the legal aspects of a contract, but we can't address the business aspect we would defer to you to determine whether what the other party commits to do is within what you want them to do for that amount of money

VanHartsevelt-it's a binding contract what we understood from the proposal from Mr. Phillips I remember being told there will be no upfront cost are the lawyer saying that if you signed this contract you're going to have to pay the \$75,000 and there's no one here to explain why the change

Lawyer - that's correct that's correct

Bryant I would like to remove it from the agenda until Mr. Phillips can come in and explain it to the mayor and counsel to explain why he said there is no charge and

there is a charge so we can strike it off the agenda for tonight, but I still want to leave the historic preservation

Fred-there has to be a second for that the second has to agree

Eason 2nd

Fred you have to say you agreed to removing that part of the motion

Bryant raised hand

Marshall I agree to remove that part about their approval for the master plan

Chief Woodward- Fire Department has seven motor vehicle accident we had one elevator incident one elevator inspection, especially this month for the apartments for the services storage fittings or finance American furniture fire drills completed this month were Fort Valley State University, Fort Valley senior center. The learning choice for valley Hart for events that citizens Academy one Methodist Church. The fire department itself doesn't have any events coming up. This month but for the month of June, we have our smoke detector, blitz and we'll have movies on the yard. We did some 40 hours completed by Lieutenant oats and we had 40 hours completed and leadership of Lieutenant Walker 16 hours of personal protecting equipment 15 hours of ropes and knots 15 hours of tools and 16 hours of ventilation that conclude the fire department report any questions

Marshall-chief have you got any SMS about your popcorn machine yet?

Chief- I have been looking over some and they need to speak with the mayor because we need to get for

Mayor- have a question Bryant

Bryant- no we had an application from Stinky when he was here. It was not complete, because he was not given the right information. It has been Miss Titi. everything has been checked off as of on his application, because they didn't give him the right information. It's not his fault. Lieutenant Jackson, but she's made everything right.

Mayor- we put them on for next month we just went through this on Tuesday

Bryant- I know, but he was not giving the right information and now that she saying that he's completed that

Mayor -again like I said

Bryant- all right

Mayor- we already approved this agenda and that's just for information purposes next is the police department

Chief Flores- Mayor, council, this past weekend we responded to 159 call services and in those calls for services we investigated to death a total 03

assault we may win rest 5/5 death by taking a motor vehicle was born as Mrs purchase was one and damaged property had a total 408 hours that was completed by Mr. Tyler Rogers, who graduated from the police Academy and is currently in the process. We also have three officers they to do the class and successfully passed it. and they just has finished their final completion of the speeding yeah but it slow down. We have three cadets in the police Academy at this state and they're in their second week so they passed the first two test and they've moved on to the third week. this past month we corrected fines with the for 26,000 577,000 for the year today thousand and 82,839. We also have had the interest program that we had this past month with the juveniles to teach them how to, reduce violence in the community and also on how to reduce the dealings with individuals more assessable officers in the community. The only thing that we have through the day will be workdays will be spring fling festival that we have all officers that will be at the event and what we have done this past month that changed our process at the police department to add more officers on the road so we have more visibility of the officers on the road and the reduction of crime and that's what I have

Mayor we saw a lot of them rush out. Is everything OK?

Chief Flores- it was just a disturbance that happened at one of the stores were we previously had a incident that happened in last Friday because we're trying to get over there so thank you

Mayor- Public Works

Walter Johnson-good afternoon council in the city of Fort Valley. The report from public works are gonna start off with sanitation will the lake Goodwill and Oaklawn cemeteries if you notice there has been remarkable improvement and each one of those cemeteries everybody's designated to the graves and loans are great, great and in peace when you go out there just visit your loved ones. You can sit back there and you can see the improvement with things to City account for getting his nice equipment to maintain those cemeteries and we also cross the roadways on Taylor Road and Chris Road and Highway 49 we trick JAMES on daily when we can't cook grass and we maintain the report for the month for park throughout the city for valley we cut the grass is each of our parts you can see a remarkable improvement throughout all the cities of Fort valley and maintain for Val they are beautiful and they are thriving and a lot of people walk by and they just take pictures of the beautiful roses but the stormwater report for 18 and 1064. We picked up the community cut the grass on the curb clean up the gutters and all that collection stormwater driveway Road for 122 hours cross railroad Street North St., Macon Street 4th St. and Broadway and street sweeping 52 street hanging baskets we're gonna hang in the baskets with the different flowers that the club gave us will put them downtown and we put a

new spruce and we can test to that and and we put up a privacy fence at the city of Fort Valley Public Works so that the Bri and stuff won't go all over the yard and the shop report for the month. We came on four police cars, two sides and charge air filters for police car and we put up a fence like I said we put up a fence bid and replace all tires up in the tires for the tracks for the shop and the sanitation report for the month because we had 702 West St. 400 and Samuel Dr. and for the service calls for Cox we work 37 for picking up yard debris throughout the city, Fort valley and those are the things that we did with the knuckle blower help landfill help with the front loaders to house demo demo removal building maintenance replace all air throughout the city for valley and the code enforcement. Awful put a light in Shop and the bathrooms at Fassel Park and then unclogged the drains. We put replace four lightbulbs barrels on ACU and we had 14 pounds of Freon and lighting and the backside of the park works, like I said might be gave you some pictures so y'all can look at well that concludes the port for the month for the city of Fort Valley. Do I have any questions?

Howard -did you get the road bump going to South Peach Park?

Johnson -working on that process we put some out and over by the Peri extension and they were planning on coming up to the stop. We're going down.

Howard -to South peach Park

Johnson- we have some more we have to add to it and on Calhoun Street

Marshall- we really do appreciate you all Mr. Walter with everything y'all do to help with the City. I really do appreciate the fence or the duplex apartment they're going to have behind public works so the fence is on that line.

Walter- fence, one of the wood fences on the property so they won't have to look at our debris and stuff in the back. In the meantime we did move a lot of our debris because of that apartment complex that they're putting over there and that will keep down the smell so we have to do that daily to make sure they make sure nothing out there and everything is covered up.

Marshall -another thing it was straight and you could see the nail on the

Johnson -they were it was street too so that should be fixed

Marshall -yes sir thank you I just wanted to make sure thank you sir

Fred-Mayor, I want to come in you guys. I thought I was doing something thank you Mayor Lundy and I said what I did on person Street. They've been cutting in

the road and stuff like that and when I got close to home, I seen the line that was cut I want to say thank you for keeping our street looking that good and you had mentioned about about the baskets in the garden club. They had requested that we tried to ward them twice a week so that the ones in the basket they will continue to bloom and blossom.

Walter- yes sir, we can make that happen

Mayor- Economic Development

Bryant- he (Gary Lee) is not here, but we have he did in the project that he was worked on, but once we get the information we get all we will gladly share
