Mayor Lundy-Lieutenant Hunter If you can give us an sergeant of arms protocol, kind of thing I was just how we the decorum of the room if you don't mind i'm putting you in a spot tonight

Lieutenant Hunter -we accept everybody be respectful and courteous and if you want to speak, make sure we speak in order we don't need to speak out of turn no profanity no fighting otherwise you will be escorted out

Mayor Lundy-and also if you would if you were cell phones or anything like that we asked that you put those on silent so that it doesn't disturb the decorum of the meeting itself thank you all. Council you have it before you the outline of today's agenda, and we need a motion of the approval of that agenda any corrections that's needed

Council member Bryant-well see I have some items I want to discuss one is the APRA the contract

Mayor Lundy- That's number seven

City Administrator Lee- that's the grant specials of Georgia

Counseling member Bryant- OK all right

Mayor Lundy- we just need the approval for the outline of the agenda

Council member Bryant- I still got some other stuff... I wanna talk about the vehicles, the nonessential vehicles that's being carried home

Mayor Lundy-what I'm saying is

Council member Bryant-That's not only the agenda

Mayor Lundy -For the agenda we need approval for the agenda that's outline before you we need a motion for approval

Council member Bryant -I would like to add these to the agenda before we approve it. Mayor Lundy- once we make sure that the agenda is approved then we can make amendments to what's on the agenda but add more items to it we would have to go into executive session

Council Member Bryant-these are not executive session.... These are not warranted to go into executive session. Or should I say these are citizens complaint.

Mayor Lundy- like I said for this like I said we have prepared the agenda for tonight and we're here for the approval for the agenda that is outline yeah ample amount of time for that

Council member Bryant -well this is work session it shouldn't be a problem to talk about the discussions in the city because it's work session is not council meeting

Mayor Lundy-you want to say something, Miss Heather

Recorder Heather-no I was just saying pause so I can catch up on the minutes Mayor Lundy- Oh ok...I just need approval, your points were noted, Council woman Bryant.

Councilman Bryant, -it's also not on the agenda the housing Authority appoint, That needs to be on here we have that we've had that for seven months and it's never been brought before the council for approval and they need two more members. They couldn't get a grant because they didn't have the a quorum

Mayor Lundy-appointment noted on that still need a motion for the approval of the agenda that's outline

Councilmember Bryant-I make a motion to approve the agenda with the mention added additions to the agenda

Mayor Lundy-great let's move to the second motion with the mention of the added to the already agenda, that's been asked for approval all in favor with that by the word I Council members-I

Mayor Lundy-agenda passes

Mayor Lundy-next item review that should be your packet is the minutes are the minutes for review for the work session meeting and city Council meeting

Mayor Lundy-Next item on item number six announcements just a couple for right now one is the peach festival The peach festival will be May 31 through June 1 in Fort Valley and on June 8 and Byron, Georgia Peach County high graduation will be on May 24 at 9:00 AM according to the are there any other announcements council that you wanna add please so at this time

City administrator Lee- maire are all. Are you going to attend the graduation I just wanted to make sure so that I can

Mayor Lundy there are three other events on that day that's on my calendar so I can't commit at this time but there's some other things that you takes place on for what is the police memorial that to be taken place in the same date and also there's another meeting that I think that the utilities commission is that at 3 o'clock so that we will try to flex the availability accordingly

Mayor Lundy-next item number seven person wishing to address, mayor and council, miss Freeman where are you and she's here

mayor Lundy-let me just read this decorum thing again for those that just for the person wishing to address mayor and council you know you fill out this form and so it reads no person should be allowed to make obscene derogatory remark that disrupt the orally conduct of immediate no person should disrupt or interfere in any way with the orderly conduct of the meeting remarks shot in with a speakers a lot expired time speakers may respond to questions from the mayor and council members should clarification be necessary provided however no person should be permitted to enter into discussion with the Maire council member or any member of the city of Fort valley staff during the conduct of a meeting so I just wanna do that and we welcome you and at this time we turn it over to you and usually we allocate five minutes and if needed more time you know we take that under consideration

Mrs.Freeman-first and foremost I would like to give my regards to counsel, Mayor Lundy, I see you over there judge Lee. I come for you in regards to the property of my late mother-in-law, Miss Freeman. I think I brought this to your attention. Judge Lee doing the time I said your office briefly within to see Will to become of the property, as well as the everything that comes along with it because my husband vehicles and and the property itself, however I brought, I have some documents pertaining to the property because of the condition my husband, death certificate may certificate we're still married at the time of his death and his deceased brother as well my attention that all of the assets and stuff that was left has not become my property however there's some issues with the property that I talk to you about the other day Mayor Lundy, with the house You did mention that you are we only able to give me a personal opinion.... Mayor Lundy -personal opinion?

Mrs. Freeman personal option, public opinion, whichever maybe I heard you wrong. I'm just here to see I need help is what I'm saying asking for help to Bring this property back up to par. I'm sure many of you here new Miss Freeman. She was from Fort Valley. She was an educator here. She might've talked some of you as well. She also was over Habitat for Humanity. at one time, I did try to reach out to Habitat for Humanity because she did see if maybe they could come along and help with the property, I dont know what to this is my first time having to do this so I just trying to ask for help. Mayor Lundy-what kind of help is it that you're asking for? can I revisit our conversation from the other day.

Mrs. Freeman-sure

mayor Lundy -for the audience sake Mrs Freeman came to me the other day and she shared with me some thoughts about the property that she is referring to, and the property is heir property I believe, and so there are two there are a niece I think there's something has to do with the property and so that she engaged with going forth things like that and she was told that this was a silver matter and this will need to go to probate for a magistrate court because there's a clarification and so I did go when she asked me to look at the property. She said she put the cameras up and stuff like that and then they move the cameras and things like that and then I stopped on the side road because they have no trespassing signs out there, but they do have a big tree live that fell on the property and things like that we're going forward but with it being categories as a civil matter my suggestion to her to pursue that probate court or in civil court so that they could define so she could find out what needs to happen with that so I think that she wanted to address the council, my words then were you know really we could only do a far behind and not give any legal advice or anything. I do see a code enforcement officer, so we're gonna acknowledge her stand up for me Miss Walker.

Code enforcement Officer Walker-what is the address of the property referring to? Miss Freeman -410 Lamar Street

Code enforcement officer Walker-just give us an opportunity to to look at it first because this is the first time I'm hearing of this so if we get an opportunity to look at that property and assess it and then we can try to go for from there now now with that being an heir property, that is a civil matter there's not a lot that we can do with that because but I have a lot of connections with connect with the communities that could help you with some of your as far trees removal, as doing a structure in that building we can't do anything on that we won't be able to do anything on that but 410 Lamar Street I will come out tomorrow. i'll make sure of that.

Council member Bryant-I would suggest you get a clear title, and get the title in your name and then you can do some things with it but with that being an air property, there's nothing that we can do but you can get you an attorney if you get that title Miss Freeman-and I will go about that doing how

Council member Bryant-get you an attorney and he'll tell you all the steps that needs to be taken. I see you when you can. Hi right now, but you need to clear title so you can borrow money make decisions and all that kind of stuff you're gonna have to have that to do.

Council member Marshall - what did you say officer Walker, did you say you can help her with those steps?

Code enforcement officer Walker-I can I will assist you with that and I get you to the right people over there

Miss Freeman-that's pretty much what I need like I said pretty much most of you knew Miss Freeman. She's prevalent here in Fort valley she was an educator here and highly involved with Habitat for Humanity and so since her death you know the property has just been declining and with her me being her daughter-in-law I just want the property to be brought to par so that we can reside in and Lamar Street was the street of many educators is lavender and seven others who stayed on Lamar Street and they were also affinity affiliated with Fort Valley State. You know doing a homecoming people come in and I'm still most often know this property and just not up to par is not what it used to be and I would just like to get it up there thank you.

Mayor Lundy next and the item is resolutions and the first one resolution to review the contract for the Georgia specialist I don't know how that became subject about that but we do acknowledge just the audience and and I'm trying to call the name grant special of Georgia in your packet. There are a copy of the contract for the review.

Council member Bryant-first of all is there a limit and what you can spend on one house when you bill

Grant specials of Georgia-there's no limit we're going by the chip group program guidelines which is what you guys want us to do when we formulated the program but there is no limit if the house is not up to code we have to get the house up to cause gone up in the past 3 to 4 years 45% if not more on materials so what we used to spend 40,000 thousand dollars not cause \$50,000 on it just depends on the days of the house and you have lead paint issues. We have to address them and get the proper hazardous in.

Council member Bryant-let me tell you you what my concern is have one house, I'm not gonna call the name. You have one house here that you've already spent 138,000 on 137,000 and spending that kind of money on one house

Grant specials of Georgia-we haven't spent that kind of money on a house Council member Bryant-we have invoices

Grant specials of Georgia we've spent 70 on two houses 35,001 house and I moving house on the fourth house and we're working on., We finished three houses and we're still working on four and those are in the house. There is no house 138,000. Would we had to get a home vac which was 106,000 and we're not expecting go any hard than that unless we have any issues such as lead paint with the house

Council member Bryant-i'm going off of excuse me these invoices

City Administration to Gary Lee-Cynthia Gill

Cynthia Gill-that will be me

Grant specialist of Georgia-like I said we haven't spent that much on our house. They might have been two houses might've been that much but there were a couple houses that were not up to.

Councilmember Bryant -this is a print out from my finance Director and he has a different number here and the amount with the names so I need to see a print out of what you have so we can compare it to what I finance director gave us

Grant specials of Georgia-I can do that

Council member Bryant-the print out that I have

Grant specials of Georgia can we have a copy of that?

Council member Bryant-it just has names by the invoice and the amount that was paid Grant specials of Georgia-is it OK to sit here or if we approach or

Mayor Lundy-thank you yes sir step up

Grant specialist of Georgia-have a probably right now the first three houses that we finish. The first property was 70,000. The second house was 71 694 and the third house is 35.519

Council member Bryant-we have invoices numbers and names. We don't have what you have so I don't know what you have until I see mine so we can compare.

Grant specials of Georgia-I'm not sure what you're looking at. I give very meticulous details on my invoices for each house so that we could break down for each one.

Council woman Bryant i'm just going by what we see here and that's not the information that we have here

Mayor Lundy-excuse me let me get a little bit more order up here let's do it like this will let you guys have a person that you don't have to go back-and-forth and things is what I call things so be integrity so we allow you all to at this time to repair for the council Grand special Georgia, but we would like to do is go with this information that you guys receive and go over our information so we can get back to the checks get copies of the checks in the invoices and so that they can match up for you guys, we put the copies with the invoices so that you guys can see that I have got the checks that were sent to me, but if they're any other items like the first check here that you have for her is not her there's no for that amount for that amount there is no check number. The check number don't match for, you're talking about the one with it was that you're cancel my Bryant.

I'm talking about this invoice here

Grand special of Georgia talking about is correct the next one is incorrect

Councilwoman Bryant-the next one Invoice number 1000

Grant specialist of Georgia- that one is correct Is the next one for...

Council member Bryant- the next one is for invoice 1001.... For \$15,006. Or the ones that were questioning the next one will be 1002.

Grant specialist of Georgia 30, 38,275 right there

Councilwoman Bryant- that's 20,000 Grant specials of Georgia- I'm talking about where you coming in with the 137,000.... 38,275 is not for a house that's for another house that is for the second name on the list right there that's the house that's why we try to keep copies of the checks so that we can match with the invoices.

Council member Bryant i'm just looking at this spreadsheet there's a new spreadsheet that has the invoice the address and the amount and then that way we can compare with our finance Director gave us.

Grant specials of Georgia OK I don't know what the issues I know I copied and paste maybe with something that was a mixer where they got the address and the name

Wright I don't think that's the case but I could've done that because I did copy and paste some things trying to get the contractors in as I will copy and paste over so things Council member Bryant give me the things that you have and we can compare to see if there are some discrepancies we can't spend \$100,000 and we have 500,000 people on one house.

Grant specials of Georgia well we do have to get the houses to code. We can't do and is difficult these days to bring a house to cold. I can actually tell you that the chip will 400,000 we were doing for five or six houses with 400,000 so this money is about the same amount so we are on track to

Castle McBryant so so you keep saying you formed it as a chip grant style but Grant specials of Georgia yes we did. We were told that this would be formed as a chip grant so that's what we got to guidelines from

Calcium and O'Briant I know the houses have to be inspected and in-house. We have inspectors that are license for arsenal and asbestos.

Grant specials in Georgia we don't have to test for that

Council member Bryant we have people in house that can do that that will help cut some of the cost when we do that after we could try to save a little money to help with the cost

Grant specialist in Georgia we don't have to test for that. Even hood does not require for us to have to test for that. The neurosis when we're building a house we don't have to. The contractors only handle the stuff like debris as they would and any of the house that they were working on anything with hazardous and stuff that's different.

Council member Bryant- i'm more concerned about money we will get our monies together and have to say once you get your spreadsheet together, we can compare it to our

Mayor Lundy-I want to make sure I gave I have Eason and Marshall a chance so let me get them opportunity to speak

Council member Eason-i'm not satisfied with your answer. Let me just clarify that I'm talking about your copying and pasting

Grant specialist of Georgia -no.....

Council member Eason- ma'am what we received from the finance Director invoices from you and what he sent out was checks to go with those invoices and what we have is names as in two houses and I don't have this list of names what you're telling me is that you did more than two houses and what I see that went out it's over \$400,000 ma'am I'm not done thank you and so what I need to see because I'm over finance. I don't need to see any copying and pasting what I need to see is what you sent our finance Director per house and what was charged and where those checks are, that's what I need to see and until I see that I need for us to put a halt on this Grant specials of Georgia-well we have four houses under contract. I can get this information to you tomorrow tomorrow.

Council member Eason I don't feel comfortable giving a dime until we Because these Dont invoices we have don't match this copy and paste. It is not matching with what we

Grant specials of Georgia when I say copy and pasting, we are contracting. You can price everybody stuff and you paste it here everybody copies, and paste with the same thing.

Councilmember Eason -no ma'am I don't copy and paste anything

Mary Lundy let me let me interject we are under contract that we under so let's wait before we stop before. Something is a small is understanding we will be provided right so we will how many houses that are currently under at this point.

Grant specials of Georgia we have four houses that were currently

Mayor Lundy- OK, any of those houses? How many are already done or any of our citizens have to say they are non-satisfactory, or anything about the word that you done Grant specials of Georgia- no

Mayor Lundy- OK then

Council member Marshall-we are to be good Stewart Maire. I'll probably you saying that we have a respected to the interrogating and to the cities of Fort valley to be good scooters with the money that came down from the body. Administration therefore will reset with that there are some discrepancies counsel Eason is over finance. I understand what she's saying. I'm backing what she's saying that I do have a problem with money being spent without a cap from my understanding when I worked on the chip grant for Fort valley \$300,000 came down. There was a cap for 30,000 for 10,000 which made \$300,000 therefore we can have a government body can count money if we like to on each house because which the way is going I have my neighbor my name is on the list. I'm waiting to get the floor done whatever you know so we got to be fair to everybody and we have to be good stewards you know \$70,000 will help somebody else and some kind of way with their bathroom or something. I have no problem with was done before I was seated on the bench, but it's a new day. You know it's a new council. It's a new government body here therefore I want to be with somebody see me out there and say Miss Sandra was going on with the money you know my floors I need this on the list and I can be able to say something so you know I have a problem with it and my thing is with that being said you know we will look at the contract, the paperwork finance and all of that, and delete of our finance committee chair and that's Miss Londa Eason and that's what we're gonna do so I wanna know how can we stop this hault or what the word being used it will run out of money trying to help the lady over there and Griffin who needs don't want that to happen to her

Grant specials of Georgia I understand we are they can do that

Council member Marcia, but we can't put a cab. I don't understand why I didn't put a cap. Your responsibility when we hired you to give your contract to do the work.

Grand specials of Georgia - and we're following all the policies and procedures I will get everything

Council member Marshall I understand the procedures you're trying to argue trying to be argumentative and that's disrespectful

Mayor Lundy-let's get back to the chair OK when we first came to this allocated monies from the opera funds that we dedicate we will have a housing, but we put out a list and that list we put out a notification that you had to come down to City Hall and fill out an application return it and they fill out the application sign for the program so we had over I think at least 75. We had 150 people on that list, so with that, what I do know, we didn't do some of the things that you're talking about about the cap number on that well under our chip grant and I made this that was a form that was a set to tear down of the back up from the signed up, which proceed what we're talking about now under the chip grant so with that, we know that there are a great leader for valley all over to preserve so make sure that the misunderstanding is making sure that I ministry of staff communicates with you all and so that it doesn't seem as though these terms to because I citizens underrated the rules and regulations by the chip format and they are doing. They are

calling folks and they're explaining you know different type of things because I don't got the same phone calls too and I don't have to reach Percy behind that what they're doing is there making sure that all those kind of things that respect that process and process and all the qualifications we just don't want to understand everything like that with that respect so those who did meet those qualifications and so we have a better understand what we're trying to do this ARAPA

COUNCIL MEMBER BRYANT THERE SHOULD'VE BEEN A CAP OVER \$50,000 PER HOUSE. WE DO HAVE A LIST AND SUPPOSEDLY BY THIS LIST IT WAS A FIRST COME FIRST SERVE HOWEVER WE GOT A WHOLE LOT OF EXTRA BUT WE SHOULD'VE HAD A CAP PLACED ON THESE HOUSES FOR THIS CONTRACT FOR AMOUNT OF DOLLARS TO GO INTO EACH HOUSE, HOWEVER, I STILL WANT TO SEE WHAT YOU HAVE ON YOUR FINANCE SO I CAN WHAT WAS SPENT AND COMPARED TO WHAT OUR FINANCE DIRECTOR HAS give us and then we'll come back and then we'll be able to see what we spend, but I do realize that with the standards with the house we don't have to make a c castle.

Grant specialist of Georgia- I understand that I mean

Council member Bryant-I'm not this is not for an argument. We just need to make it now we need to get to. We need a list to see we need spreadsheet so we can see Grant specials of Georgia I completely understand when you see something like that I can completely understand where the confusion is coming in OK and I will be gladly to get the correct information out to you. I wasn't being argumentative. I was just doing what I was in charge of doing and I was just a little confused cause I was told to do it like the chip Grant and we just had it off of the chip grant I have no problem getting you guys the information and doing everything about that.

Council member Bryant- we should've had a cap on it. We should have a Cam is not go into that. I just need. I'm concerned about the monies.

Grant specials of Georgia-chip Grant doesn't put a cap on it because you have to bring the houses up to Cole and you do not know the cost for that and it's been like that that is a chip guy you have to bring the house up to

Code

Council member Bryant I understand that I knew a contractor he used to be that way so I understand what you're saying. All I want is documentation to make sure that what we have and what you have is accurate.

Grand specialist of Georgia and we are doing it on first come first size. We are all in the first page. I didn't know three people on the first page and you don't you can't I didn't think about that first page was just you know you just qualify.

Mayor Lundy-can we acknowledge Mr. Lee

City administrator Gary Lee-what I would like to do. I will contact you all tomorrow and then I will get with my finance Director and we will compare and we can get together in regards to what we have.

Grand specials of Georgia that's fine. I'll be glad to get you the information and we can you know compare and contact after you get the information from the finance Director. And I just wanna make sure we do follow our procedures and we do know what we do if affect cities so we just try to make sure that we follow with the documentation when I like to clarify that we do get the information from the finance Director and advise and we try to get that to you guys. Otherwise we clarify we get it you guys get the right information and then when you have everything and that we have any question thing anything like that you guys Could take care of so that we have a couple ladies here who

are working on their house we have some of those finished so we can revisit tomorrow so I just wanna make sure that we can be clear that we can continue to work on the houses that occur in a contract

Councilmember Eason yes the four has that you're working on

Grand specials of Georgia I guess what I'm asking is do we have permission to continue working on the four houses while we provide with the documentation of the houses that we've already completed?

Council member Eason how many houses are you currently working on?

Grant specialist of Georgia-we finished with three and currently working on four

Council member Eason so you finish with and you're working on four

Grant specialist of Georgia- correct and I will get you the invoices for the ones that are completed and we just wanna finish the four houses and we have a couple of ladies here that can speak for them. Take care of their houses.

Council member Bryant- I'm not worried about nothing but the money I just wanna know what we spent doing now and where we are

Council member Marshall I just need to see how much was \$1.3 million was still in there. How much is left from the houses and what was spent and then was set aside for each house and I just wanna see what was spent of the \$1.3 million.

OK, the 1.25 million of the 1.25 me I want to see what it cost three houses how much do we spend on this?

Grant specials of Georgia 175,000

Council member Marshall I'm just trying to get the number of what was spent so you said 175,000 so it was 172,000 for three homes out of that 1.25 million that was set aside from my understanding, I thought we were just going to go down and fix a bathroom and fix the flooring or

Grant specials of Georgia-that was the original plan but we have to bring the houses to cold and then you know so we can't we can't we can't put a roof on and then have other issues we have to bring it up to code it all together

Council member Marshall- OK

Grand special of Georgia yes, we have to bring everything up to code so the amount is spend. If we realize we have an issue we have to fix it per the chip great guidelines. Council member Marshall, so the four houses that you're working on now how much will it take for those four houses to be completed?

Specials of Georgia after those four houses are completed we should have give me I need to look at up. We have she hasn't called me back. I'm just one person know what's going on if you can.

Councilmember Marshall, but you didn't answer my question the four houses that you're working on now

Council member Bryant put it on paper and we will come back. Let us see if we can come back.

Mayor Lundy-thank you all

Council member Eason complete the four houses and we will come back to it once we get the information

Mayor Lundy-thank you. Let's get the information we can come back to thank you again. I appreciate it.

Mayor Lundy-next we have approval of the alcohol license for the main event when you give any background on the main event business license packet

Council member Bryant this was completed last meeting

Mayor Lundy let them hear it let them see it

So we're gonna move for the agenda for Thursday for approval

Next, we have resolution of approval Julia Simmons Avenue number F04D0025 and F04D025Z from R2 to industrial

City administrator Gary Lee yes we for you guys to ratify that we didn't approve and ratify then he just need to come back to you guys mayor Council

Mayor Lundy-OK we got that we move that to the Jennifer for Thursday number four resolution to approve the date and time for the work session for June. I think that's because we'll be in training.

Recorder Heather yes if I'm not mistaken, you guys are supposed to have it on the third Thursday of the month but that's when you guys are being training so we just need to see exactly where it's going to fall

Mayor Lundy-I do remember in time passes we canceled that we canceled City council meeting because of that but for the charter I don't think we can cancel. We just reschedule it so that's what we're just trying to work out the logistics of that so we can take a vote or no we just had to make it at the same time. I know the time pass we just canceled it, but I think we just need to reschedule.

Council member, we just need to do everything at one time so that way if there is a way we can get that and we can make it on the same time on Tuesday

City Administration Lee -we can do one meeting at four and the next one at six O'clock council member Bryant will do all together

Recorder Heather -let me just make sure we don't have court that day because if we have court, I just wanna make sure we have every time to

Council member Bryant is our regular schedule day so we should be fine And it would be the same time

Mayor Lundy-is there any anything else we need to?

Council member Brian, the advertisement is done. Everything has been done. We just dropped the ball in regards to appointing the members so we just need they just need to have their two applicants and we just need to go forward getting those appointed.

Mayor Lundy- OK thank you guys for coming you were about to go into executive session so we thank you guys for coming Heather make sure you take care of everybody online. Mayor Lundy-all right thank you guys. We did meet with a personnel and everything over

City Administrator Gary Lee-hold up one second we have our peach festival coming up and we at the punchline where a week away and they have to be authorize 15,000 for them for the festival and I think that she miss Horton would you like to come in address? Mayor Lundy-put on agenda for Thursday?

Councilmember Marshall-I have a quick question about it don't we have a lot item already for the peach festival don't we already?
